CIRCULAR

Subject: REGISTRATION OF INSTITUTIONS OFFERING ALLIED HEALTH DISCIPLINES WITH THE ALLIED HEALTH PROFESSIONALS COUNCIL (AHPC)

Respected All,

I am pleased to inform that Allied Health Professionals Council has been established by the Government of Pakistan through Allied Health Professionals Act, 2022. The main functions of the Council are to define the scope and standards of study, to register AHPs and institutions, and to facilitate their continuing professional development.

2. The Allied Health Professionals Council wishes to draw attention to the following:

(a) Section 12(1), (4) and Section 18, 19 of the AHPC Act 2022 stipulates that

“Any institution, which provides courses for basic or higher qualifications for various Allied Health Professionals in Pakistan, shall apply to the Council for registration/recognition and shall furnish the information as required by the Council”


(b) Section 16 (1), (2), Section 20 of the AHPC Act 2022 stipulates:

“The Council shall for the purpose of registration of AHP maintain the register of Allied Health Professionals”.

3. The Allied Health Professional Council (AHPC) is **proceeding with the registration of institutions of Islamabad/Rawalpindi offering allied health disciplines, their faculty members and students.** (List of allied health disciplines is attached).
