CIRCULAR

Subject: LAST DEADLINE FOR PROVISIONAL REGISTRATION OF UNIVERSITIES/ INSTITUTIONS OFFERING DEGREE, DIPLOMA AND CERTIFICATE COURSES IN ALLIED HEALTH DISCIPLINES.

Respected All,

Reference to previous circulars No.3/2023/AHPC/55 dated 2nd November, 2023 & No.7/2024/Institutes/AHPC/209 dated 13th February, 2024 and to inform that Allied Health Professionals Council has been established by the Government of Pakistan through Allied Health Professionals Act, 2022. The main functions of the Council are to define the scope and standards of study, to register AHPs and institutions, and to facilitate their continuing professional development.

2. The Allied Health Professionals Council wishes to draw attention to the following:

(a) Section 12(1), (4) and Section 18, 19 of the AHPC Act 2022 stipulates that

“Any institution, which provides courses for basic or higher qualifications for various Allied Health Professionals in Pakistan, shall apply to the Council for registration/recognition and shall furnish the information as required by the Council”

(b) Section 16 (1), (2), Section 20 of the AHPC Act 2022 stipulates:


“The Council shall for the purpose of registration of AHP maintain the register of Allied Health Professionals”.

3. The Council in its 5th meeting held on 25.04.2024 has extended the final deadline for submission of registration form **till 3rd May, 2024**. The list of institutions registered so far is available on the website <https://ahpc.org.pk/registered-institutions.html>

The universities/institutions are requested to fill the form, complete checklist and attached relevant documents as per guidelines and submit soft copy to ahpcnewreg@gmail.com along with hard copy till **3rd May, 2024**.
